- The number of sections in the school are restricted to 49 as per number of sections reported by the IC and shall 9. not be increased without specific approval of the Board. For increase in number of sections, the School shall apply online to the Board as per rule 15.7 of affiliation bye laws.
- The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity related to running of school affiliated to CBSE. The school shall also be liable to bear all legal charges incurred by the Board, if any, arising out of these circumstances.
- The school must strive to promote conservation of environment on their campus through rain water harvesting, segregation of waste at source, recycling of organic waste, proper disposal of waste including electronic waste, use of energy saving and energy efficient electrical equipment, greening of campus, use of solar energy, education and awareness amongst children on environment conservation and cleanliness etc.

- The optimum Section teacher ratio of 1:1.5 as well as student teacher ratio of 30:1 is to be maintained to teach various subjects and school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.
- Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class XII examinations from the year mentioned while granting affiliation/upgradation regularly without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates.
- Running of coaching institutions in the school premises in the pretext of providing coaching to the students for various examinations is not permitted by the Board. Strict action would be taken on defaulters. 15.
- The Manager and the Principal of the school shall be jointly responsible for the authenticity of the online/offline 16. documents/ information/data submitted by the School to the Board.
- Apart from rules to be adhered to by the school as mentioned above for drawing specific attention of the school authorities, the school authorities are required to acquaint themselves with all the rules contained in Affiliation & 17. - * As per the appointment letters submitted the school has appointed 9 PRTs and 1 TGT . Thus the school is still required to appoint trained and qualified 2 TGTs to maintain section teacher ratio i.e. 1:1.5 of affiliation bye-laws of the Board and submit documentary evidence.
- * The Structural safety certificate is issued by a PRIVATE FIRM, thus the school is required to submit Building Safety Certificate issued by Competent Government Authority (like PwD etc) in the required format as per affiliation byelaws.
- * The school has submitted lab report for safe drinking water vide diary no. 1983 dated 06/12/2019 issued by Asstt Chief Water Analyst ,Delhi Jal Board, Government of NCT of Delhi but the school is required to submit Safe drinking water certificate as per the format given in appendix VIII of affiliation byelaws 2012, which should be issued by competent Government authority (like CMO).
- * The revised videography link submitted by the school : https://www.youtube.com/watch? v=6QpKtbolBRU&feature=youtu.be Even the new video submitted by school does not cover the four pucca boundary walls of school campus properly as so many buildings are seen in the video that it is not possible to point out where and which one is school premises boundary wall. Thus, the school is required to upload videography covering the school from main gate covering the outer campus, four boundary walls of school campus from all the sides. in such manner that school boundary wall may be differentiated and seen properly.
- * As per IC report, THE SCHOOL MAY BE GRANTED EXTENSION AND ASKED TO WORK ON THE EARLIER REMARKS PROVIDED. SINCE THE SCHOOL IS DOING MANY ACTIVITIES TO GROOM STUDENTS SO KEEPING IN MIND THE EARLIER AFFILIATIONS GRANTED THEY MAY BE DIRECTED TO FILL THE LITTLE GAPS WHEREVER REQUIRED AND GIVEN A GO AHEAD. Thus the school is required to do the needful to FILL THE LITTLE GAPS WHEREVER REQUIRED.
